Active Membership

Sworn Law Enforcement Officer currently serving as an Agency Head, and actively serving Command Staff Members designated by the Agency Head (Agent in Charge or equivalent of area State and Federal Agencies is considered an Agency head for purposes of membership).
Sworn members of a Sheriff's Office may join the Association, as an Associate Member.

Associate Membership

Sworn Law Enforcement personnel that previously held an Active Membership in the Association; Retired Law Enforcement Command Staff; Current leadership of organizations that directly support the role or function of law enforcement that are recommended for membership by the Executive Committee. Associate membership may also be granted to the CEOs of Miami-Dade County, and of the municipalities located therein, and *Sworn members of a Sheriff's Office.*

Future Leader Membership

Available, with the written endorsement of their agency head, to Sworn, non-command personnel that would not otherwise be eligible for membership.

Life Membership

Life Members are afforded permanent "Active" membership regardless of their membership qualification status. This includes all past Presidents. May also be granted to any individual deemed to be deserving of the honor by unanimous vote of the membership at an Executive Meeting.

Honorary Membership

Honorary Members shall be persons that the Association chooses to honor with such status.

Sponsor Membership

Sponsor Membership may be granted to those business entities, either individuals, partnerships or corporations who seek to support the Association. Member status is granted to the Principal and one other individual designated by the Principal.

Associate, Future Leader, and Sponsor members shall have the privilege to wear the badge of the Association.

Only Active and Life members shall have the privilege of holding office in or voting on matters of the Association.
